As coronavirus soars, U.S. cheers Britain's vaccine approval

NEW YORK (Reuters) - U.S. health experts on Wednesday welcomed British emergency approval of Pfizer Inc's COVID-19 vaccine, a sign that U.S. regulators may soon follow suit in a bid to bring the surging pandemic under control.

As U.S. coronavirus hospitalizations jumped to their highest since the onset of the global pandemic, Britain gave emergency use approval to the vaccine developed by Pfizer and German partner BioNTech SE, the first country to do so.

Britain said it would start inoculating high-risk people early next week, a move that could make Americans more confident about the prospect of an expected mass vaccination campaign reminiscent of the anti-polio campaigns of the 1950s and 1960s.

"This should be very reassuring. An independent regulatory authority in another country has found this vaccine to be safe and effective for use," U.S. Health Secretary Alex Azar told Fox Business Network on Wednesday.

U.S. COVID-19 hospitalizations hit a record for a fourth consecutive day on Tuesday, approaching 100,000, according to a Reuters tally. At the same time, exhausted healthcare professionals are short-staffed, with many of their colleagues falling sick.

Another 2,624 U.S. deaths were reported on Tuesday, the fifth-highest daily total on record, raising the cumulative death toll above 270,000 since the pandemic began. At least four states - Illinois, Kansas, Minnesota and Oklahoma reported a record increase in deaths on Wednesday.

Although China and Russia also have moved ahead with inoculation campaigns with their own vaccines, Britain's medical standards more closely align with those of the United States.

"It's got major significance being that it's the first Western country to approve the vaccine for a roll-out and start administering it to the public," said Kirsten Hokeness, an immunology and virology expert and chair of Science and Technology at Bryant University in Smithfield, Rhode Island.

"It's going to put a little pressure on us to rapidly evaluate the data," Hokeness

Moderna's vaccine, which employs similar technology as Pfizer's and was also nearly 95% effective in preventing illness in a pivotal

Of particular interest is how Britain manages the Pfizer vaccine's requirement to be stored at minus-70 degrees Celsius (-94 Fahrenheit). Moderna's can be kept at more normal refrigerator temperatures.

But the British experience is unlikely to factor into U.S. regulatory approval, which instead will focus on the clinical trial data.

THE SINGLE MOST IMPORTANT TOOL

While some U.S. health officials described a timeline that assumed FDA authorization would come within days of the Dec. 10 meeting, others have said it could take weeks.

"Surely we want a vaccine available as soon as it is deemed safe. We want to make sure that we can provide accurate information to the public," said Dr. Lisa Costello, a professor of pediatrics at the West Virginia University School of Medicine who is helping advise West Virginia's state government on vaccine distribution.

Virginia Governor Ralph Northam expressed confidence in the safety of the vaccines at a news conference on Wednesday.

After all, we are still very proud that our democratic system is working and working very well.





U.S. Passes 13 Million COVID-19 Cases

WASHINGTON — More than 13 million third Friday, could be adjusted as more cases of the coronavirus have now been reported in the United States, the third time the country has recorded a million infections in less than a week.

For the third week in a row, it took six days for the U.S. to count another million cases of COVID-19. The country had 13,088,282 cases on Friday, according to Johns Hopkins University. The U.S. reached over 12 million cases

With coronavirus cases rising across the country, the Centers for Disease Control and Prevention had urged Americans not to travel for Thanksgiving. Federal health officials instead encouraged everyone to celebrate at home with those they live with.

The U.S. is still missing nearly eight coronavirus infections for every one counted. By the end of September, the Centers for Disease Control and Prevention calculates that as many as 53 million Americans had been infected. That is just under eight times the confirmed cases reported at the time.

A panel of CDC advisers will meet Tuesday to vote on how scarce, initial supplies of a COVID-19 vaccine will be given out once one has been approved. Experts have proposed giving the vaccine to health workers first.

Los Angeles County announced a new stay-home three-week order amid a surge in coronavirus cases in the nation's most populous county taking effect Monday. COVID-19 deaths are also on the rise, though not at the record high numbers reached in the spring. The seven-day rolling average for daily new deaths was 1.441 as of Nov. 21, more than 33% higher than it was a week prior.

The virus has now killed more than 264,000 people in the U.S., according to Johns Hopkins.

Worldwide, more than 61 million coronavirus cases have been reported with more than 1.4 million deaths. The U.S. has about 4% of the world's population, but about a fifth of all reported cases. It took 312 days for the U.S. to hit the 13

million mark since the first case was diagnosed in Washington state on Jan. 20.



Vaccine Distribution Principles Developed By Expert Vaccine Allocation Panel

Governor Abbott, DSHS Announce COVID-19 Vaccine Distribution Plan

(November 23, 2020 | Austin, Texas) -Governor Greg Abbott and the Texas Department of State Health Services (DSHS) today announced the guiding principles for Texas' COVID-19 vaccine allocation process, which will serve as a foundation for the state's initial distribution for COVID-19 vaccines expected as early as next month. These principles have been established by the Expert Vaccine Allocation Panel (EVAP), created by DSHS to make recommendations on vaccine allocation decisions, including identifying groups that should be vaccinated first to provide the most protection to vulnerable populations and critical state resources.

"These guiding principles established by the Expert Vaccine Allocation Panel will ensure that the State of Texas swiftly distributes the COVID-19 vaccine to Texans who voluntarily choose to be immunized," said Governor Abbott. "This foundation for the allocation process will help us mitigate the spread of COVID-19 in our communities, protect the most vulnerable Texans, and safeguard crucial state resources."



Texas will initially allocate COVID-19 vaccines based on the following crite-

- Protecting health care workers who fill a critical role in caring for and preserving the lives of COVID-19 patients and maintaining the health care infrastructure for all who need it.
- Protecting frontline workers who are at greater risk of contracting COVID-19 due to the nature of their work providing critical services and preserving the econ-
- Protecting vulnerable populations who are at greater risk of severe disease and death if they contract COVID-19.
- · Mitigating health inequities due to

factors such as demographics, poverty, insurance status and geography.

- Data-driven allocations using the best available scientific evidence and epidemiology at the time, allowing for flexibility for local conditions.
- · Geographic diversity through a balanced approach that considers access in urban and rural communities and in affected ZIP codes.
- · Transparency through sharing allocations with the public and seeking public feedback



EVAP has recommended, and the Commissioner of Health John Hellerstedt has approved, health care workers likely to provide direct care for COVID-19 patients and other vulnerable residents to be the first group to receive the vaccine. This includes staff at hospitals and longterm care facilities, emergency medical services and home health care workers. nate Care Site In El Paso HHS To Supply 1,000 Doses Of Antibody Therapy As Part Of Pilot Program (November 24, 2020 | Austin, Texas) -Governor Greg Abbott today announced that the Texas Division Of Emergency Management (TDEM) has established a bamlanivimab infusion wing at the staterun alternate care site (ACS) in El Paso to treat outpatient cases of COVID-19. The infusion wing, which began accepting patients today, has been provided with 1,000 doses of bamlanivimab through the U.S. Department of Health and Human Services (HHS). The ACS infusion wing is part of a pilot program developed through a partnership between TDEM and HHS.



"The establishment of the bamlanivimab infusion wing at El Paso's alternate care site is crucial to keeping hospitalizations down and protecting at-risk Texans in the community," said Governor Abbott. "I thank HHS for supporting our efforts by supplying the State of Texas with this shipment of bamlanivimab for the pilot program. We will continue to ensure that this life-saving antibody therapy is available for Texans who need it most."

Bamlanivimab, the Eli Lilly & Company monoclonal antibody therapy, is for outpatient use in people who have tested positive for COVID-19 and are at increased risk of severe disease. It has been shown to prevent hospitalizations in some patients when used before they become very
